### ANALYSING NEWS ARTICLES

When analysing a news article you look at how it is organized. News articles are divided into two parts, A strong *lead* or beginning to the article, and the *body*, or bulk of the article. The lead, which may be more than one paragraph long, answers the most important questions and often contains a *hook*, to grab the reader's attention and encourage further reading. Types of hooks include controversial statements, exciting events, and unanswered questions, all techniques to encourage the reader to continue reading the article. The body follows the lead, and fills in the rest of the details about the story. Most writers use an inverted pyramid form for the body in which the most important information is presented first, and the least important information last. In this way, you don't have to read the whole article to get the most important information.

When writing a news article, journalists answer the 5W+H questions. This is an abbreviation for *who*, *what*, *where*, *when*, *why*, and *how*. Usually, the most important of these questions are who, what, where, and when, so their answers often appear in the lead. The why and how answers frequently don't appear until the body.
